

# Conditions of Participation for the #ErasmusDays2021AT Pizza Challenge

## 1. General provisions

(1) The organiser of the contest is OeAD-GmbH – Agency for Education and Internationalisation, Ebendorferstraße 7, A-1010 Vienna (“OeAD” in the following). OeAD is accountable and responsible for the organisation, the execution, and the distribution of prizes/winnings.

(2) By participating in the contest, the Participant agrees to the following Conditions of Participation.

(3) OeAD reserves the right to change the Conditions of Participation for important reasons or to end the contest early. In this case, OeAD will notify all participants.

(4) Legal recourse is precluded. The winnings/prizes cannot be redeemed in cash.

## 2. Eligibility

(1) Natural and legal persons are eligible to participate. However, persons below the age of 18 must also submit a signed declaration of consent from their parent/legal guardian when registering in order to be eligible.

(2) Each participant may only enter the contest once.

(3) Participation in someone else’s name or using a fake name is not permitted (exception: Facebook and Instagram profiles do not have to match the Participant’s actual name). OeAD-GmbH reserves the right to exclude participants from the contest if they do not comply with these Conditions of Participation or attempt to unfairly influence the contest. In particular, participants can be excluded if their entries contain offensive or unlawful content or serve commercial purposes.

(4) Salaried employees and other employees of OeAD-GmbH may not participate.

## 3. Procedure

(1) Participation in the contest is only possible during the period from **13 September to 17 October 2021 at 11:59 pm.**

(2) A valid entry requires you to post a picture or video in your own Facebook or Instagram profile together with a brief description and to include the hashtag #ErasmusDays2021AT. On Facebook, the Facebook page “Erasmus+ Bildung Österreich” of OeAD (@erasmus.bildung.oesterreich) should also be tagged. The Participant must subsequently send an e-mail with his/her full name, address, and the relevant photo or video entry as well as the signed consent form to [erasmusplus.challenge@oead.at](mailto:erasmusplus.challenge@oead.at).

(3) By publishing the post (photo or video with description and #ErasmusDays2021AT) online as described in item 3 paragraph 2 and submitting his/her personal data and consent form to [erasmusplus.challenge@oead.at](mailto:erasmusplus.challenge@oead.at), the Participant confirms that he/she has the unrestricted right of use (including the right to transfer this right of use) for the content to be published free of charge on the website and social media channels as well as in the printed materials of

OeAD without including the copyright holder's name (express consent of the copyright holder for publication in the specified media with no claim for additional compensation and no copyright notice).

The Participant transfers the right of use to the photos or videos in full to OeAD on a non-exclusive basis, but with no restrictions on the place or time of use, for publication in the print and web media of OeAD with no separate claim for compensation and waives the right to be named as the copyright holder.

In addition, the Participant confirms that the publication of the photos does not violate the rights of third parties, particularly copyrights and/or personal rights (i.e. that the entry and the photos do not include protected content, e.g. logos or images of other people or – if this is the case – that he/she has the right of use for the protected content or the consent of the people pictured).

OeAD reserves the right to delete all posts and comments from the #ErasmusDays2021AT social wall (walls.io) at any time without providing reasons.

If claims such as claims for usage fees or other claims for damages are asserted by the copyright holder due to a violation of his/her copyright or by third parties due to a violation of their personal rights, copyrights, or other exclusive rights, the Participant will indemnify OeAD in this regard, i.e. compensate OeAD for all costs connected with the assertion of these claims.

(4) The ten most creative entries by participants will be selected by OeAD and awarded with main prizes in October 2021. The five most creative video entries will receive a travel voucher from Austrian Railways (ÖBB) in the amount of EUR 200.00. The five most creative photo entries will receive a travel voucher from ÖBB in the amount of EUR 100.00.

(5) In addition, the following prizes will be awarded among all of the participants via a drawing in October 2021:

One voucher in the amount of EUR 500.00 for participation in the Alternative Economic and Monetary Systems (AEMS) Summer School 2022 (<https://summer-university.net/aems-vienna/>); one pair of tickets for the Burgtheater in Vienna; two pairs of tickets for the English Theatre in Vienna.

(6) The selection of the winners will not be open to the public.

#### **4. Claiming the prize**

(1) The winner will be notified by OeAD by e-mail. The entitlement to the prize shall only come into effect upon receipt of the written prize notification.

(2) The winner consents to his/her photos or videos being published in part or in full with his/her first name and last initial on the website and social media channels as well as in the printed material of OeAD.

(3) The winners will be awarded in October 2021.

If the prize is not claimed, the entitlement to the prize will lapse and OeAD will award the prize among the remaining participants via selection or drawing at its own discretion if time allows. The originally selected winner will no longer have any entitlement to his/her prize when the period expires.

(4) The Participant is responsible for ensuring that the submitted data are correct.

#### **5. Liability**

OeAD assumes no liability with regard to the potential violation of personal rights or

copyrights of third parties due to the publication of photos or videos of the Participant. If third parties exercise such rights, the Participant must indemnify OeAD in this regard.

## 6. Use of data

The Participant acknowledges that the personal data acquired in connection with the organisation and execution of the contest will be collected, stored, and processed by OeAD as a controller pursuant to the GDPR and on the basis of the valid regulations.

The data processing is performed in accordance with Article 6 (1) lit a) GDPR on the basis of the Participant's consent, granted by voluntarily entering the Pizza Challenge contest and confirming the Conditions of Participation, for the purpose of organising and executing the #ErasmusDays2021AT Pizza Challenge contest in the period from **13 September to 17 October 2021 at 11:59 pm**.

The Participant – or the parent/guardian of a minor participant – can revoke this consent at any time.

By revoking this consent, the **Participant will no longer be eligible to participate in the contest**. In this case, OeAD will no longer process the Participant's data for the purposes described above starting at this point in time and will delete the data.

The right to object is precluded after the Participant claims his/her prize.

In the course of its electronic data processing activities, OeAD subcontracts to IT service providers (data processors) who may gain access to personal data of the participants in the course of their activities if they require such data to perform their services. These service providers are obligated to take sufficient technical and organisational measures to ensure the protection of the data based on the data processing agreement concluded with OeAD. These service providers are not permitted to transfer the participants' data (except in legally required cases).

The Participant has the right to gain access to his/her personal data processed by the controller, OeAD, at any time as well as the right to rectification. Provided that there is no legal retention obligation or other legal basis for the processing of the data, the Participant has the right to erasure of the data as well as the right to object to the processing.
